Proposal 1. Disestablish the Federation's Regional Wushu Associations

Reason for Change	The Federation Executive has discussed at length the merits and disadvantages of its Regional Wushu Associations and has decided to disestablish them to reduce layers of unnecessary administration, including separate bank accounts, and achieve a more transparent and easily administered nation-wide view of event planning and resourcing. In addition, the regional structure has been problematic to fully introduce with no Regional Wushu Association having ever been formed in Christchurch and Dunedin since Incorporation of the Federation on 18 July 1995.

Proposal 2. New Federation Executive Members to be appointed by existing Executive, with unanimous agreement, rather than nominated and elected at AGM.

Section/s of Constitution	17.3; 17.5; 17.6; 17.6.3; 17.6.5; 17.6.6; 17.7; 17.8; 17.9;
Reason for Change	The Federation Executive has reviewed its internal management structure and identified a strong need to increase its overall governance, management and event organising capability.
	It was agreed that new Federation Executive roles, excluding the role of President, are best to be 'appointed' by the Federation Executive, as opposed to being 'nominated' and approved by members at AGM.
	The current requirement detailed in the constitution at 17.6.5 (see below), is considered to be the wrong instrument for attracting and recruiting people in a timely manner with the right knowledge and skills and experience, especially when specific to a designated portfolio, and especially when considering the importance of team-fit is so far as being able to work harmoniously with the wider Executive.
	"17.6.5: A candidate must have been be a Constituent Member for a minimum period of two (2) years immediately prior to their nomination for election and be able to demonstrate during that time, a significant contribution to the development of Kung-Fu Wushu in New Zealand or a Region in New Zealand".

Proposal 3. Use of Federation Name and Logo by Member Clubs

Section/s of Constitution	29
Reason for Change	The Federation Executive has for some time received queries from members of the public, funders, and member clubs, as to whether certain clubs that bear a similar name to the Federation, are one and the same as the Federation, which they are not. To remove all doubt about which names the Federation has 'custodianship' of, and therefore which should not be used by member clubs, the wording in Section 1 of the Constitution NAME has been repeated in Section 29 of the Constitution FEDERATION LOGO AND NAME . Specifically, this means that unless exempted, no member club of the Federation may use any of the following as its club or organisation name, whether using English and Chinese translation: "New Zealand Kung-Fu Wushu Federation; or NZKWF; or Kung-Fu Wushu New Zealand; or Wushu New Zealand; or New Zealand Wushu; or Federation as short title". Note that the above 'Federation Names' have been included in the Federation's Constitution since its Incorporation on 18 July 1995.

Reason for Change	The current 21-day requirement to notify any proposed alteration to the rules to the Secretary, before the AGM, and the 14-days for the Secretary to then advise members advise members, before the AGM, is not consistent with common practice since the Federation became Incorporated on 18 July 1995.
	What the Federation has done to date is a four-step process, which while quite condensed timewise, has been suited to the overall size, scale and operation of the Federation and its available resources.
	Circulate the Notice of AGM to members 21-days before the AGM.
	Send the constitution and template to propose changes to the constitution to members 14-days before the AGM.
	 Request that any proposed changes to the constitution be submitted to the Secretary 7-days before the AGM, using the appropriate template.
	 Email and upload to the Federation website, a summary of any proposals to review the constitution 5-days before the AGM.

Proposed Wording	27.1.2 The alteration proposed must be notified in writing to the Secretary not less than <u>7</u> days before the General Meeting which considers the proposal;

to all Constituent members at least <u>5</u> days before the General Meeting;

Proposal 7. Election of President/CEO

Reason for Change	The current 10-day requirement for nominations for the role of President/CEO to be delivered to the Secretary "before the date fixed for the holding of the Annual General Meeting at which the election is to take place", is not consistent with common practice since the Federation became Incorporated on 18 July 1995.
	What the Federation has done to date is a four-step process, which while quite condensed timewise, has been suited to the overall size, scale and operation of the Federation and available resources.
	 Circulate the Notice of AGM to members 21-days before the AGM.
	Send the President Nomination Form to members 14-days before the AGM.
	Request that Nominations for the position of Federation President be received 7-days before the AGM.
	Circulate to members, a list of Nominees for the role of President 5-days before the AGM.
Current Wording	17.6.2 Shall be delivered to the Secretary not less than <u>ten</u> days before the date fixed for the holding of the Annual General Meeting at which the election is to take place, and;
	17.6.3 Nominations for the role of CEO/President shall be accompanied by the candidate's election manifesto covering plans for the next 3-5 years, which the candidate shall present in person at the AGM.
Proposed Wording	17.6.2 Shall be delivered to the Secretary not less than <u>seven</u> days before the date fixed for the holding of the Annual General Meeting at which the election is to take place, and;
	17.6.3 Nominations for the role of CEO/President shall be delivered by the Secretary to members not less than <u>five</u> days before the date fixed for the holding of the Annual General Meeting at which the election is to take place and shall be accompanied by the candidate's election manifesto covering plans for the next 3-5 years, which the candidate shall present in person at the AGM.
