## **NZKWF CODE OF CONDUCT MEMBER PROTECTION POLICY**

The following Code of Conduct and Member Protection Policy applies to all NZKWF members, staff, officials, advisors, team managers, coaches, judges, medical, athletes, team observers, supporters, accompanying family members and friends.

NZKWF expects the above named groups to abide by a Code of Conduct and the NZKWF Member Protection Policy, as documents that uphold the principles and values of the organisation and acknowledge a 'duty of care' to each other.

### **NZKWF Member will:**

*As a NZKWF member, you should meet the following requirements in regard to your conduct at all times including during any NZKWF sanctioned activity.*

- Respect the rights, dignity and worth of others.
- Be fair, considerate and honest in all dealings with others.
- Be professional in, and accept responsibility for, your actions.
- Make a commitment to providing quality service and performance.
- Be aware of, and maintain an uncompromising adherence to, standards, rules, regulations and policies.
- Operate within the Constitution, Regulations, Policies and Procedures of NZKWF/OWUF/IWUF
- Understand the possible consequences of breaching the NZKWF Code of Conduct.
- Immediately report any breaches of NZKWF members to the appropriate authority.
- Refrain from any form of abuse towards others.
- Refrain from any form of harassment towards others.
- Refrain from any form of discrimination towards others.
- Refrain from any form of victimization towards others.
- Provide a safe environment for the conduct of the activity in accordance with relevant NZKWF policy.
- Show concern and caution towards others who may be sick or injured.
- Be a positive role model.
- To not provide comment to any media on behalf of NZKWF Inc.
- To not speak to any media in a negative way regarding NZKWF Inc.
- Never act in any way that may bring disrepute or disgrace to NZKWF Inc. members, its Executive Board and/or its sponsors, potential sponsors and/or partners.

### **Team Manager/Leader will:**

- Agree to abide by the Code of Conduct.
- Be responsible for the overall welfare and well-being of team members and officials when travelling with a team.
- Maintain a 'duty of care' towards team members and be accountable for the management of the team.
- Have a sound working knowledge of NZKWF & IWUF Constitution, Regulations and Policies, and ensure that the conduct of the affairs of the team is in accordance with these and or any other policies and guidelines determined by NZKWF & IWUF.
- Foster a collaborative approach to the management of the team.

### **Development Squad Coordinator / Coach / Judge will:**

- Agree to abide by the Code of Conduct.
- Respect the rights, dignity and worth of every individual athlete.
- Treat everyone equally regardless of gender, disability, ethnic origin or religion.
- Respect the talent, developmental stage and goals of each athlete in order to help each athlete reach their full potential.

### **Maintain high standards of integrity:**

- Operate within the rules of the sport and in the spirit of fair play, while encouraging athletes to do the same.
- Advocate a sporting environment free of drugs and other performance enhancing substances within the guidelines of the IWUF, WADA (World Anti Doping Agency) and the New Zealand Sports Drug Agency "Drug Free Sport New Zealand" (DFS)".
- Do not disclose any confidential information relating to athletes without their written prior consent.

### **Be a positive role model for the sport and athletes and act in a way that projects a positive image of coaching:**

- All athletes are deserving of equal attention and opportunities.
- Ensure the athlete's time spent with you is a positive experience.
- Be fair, considerate and honest with athletes.
- Encourage and promote a healthy lifestyle – refrain from smoking and drinking alcohol around athletes.

### **Professional responsibilities:**

- Display high standards in your language, manner, punctuality, preparation and presentation.
- Display control, courtesy, respect, honesty, dignity and professionalism to all involved within the sphere of sport - this includes opponents, coaches, officials, administrators, the media, parents and spectators.
- Encourage your athletes to demonstrate the same qualities.
- Be professional and accept responsibility for your actions.
- Accurately represent personal coaching qualifications, experience, competence and affiliations.
- You should not only refrain from initiating a relationship with an athlete, but should also discourage any attempt by an athlete to initiate a sexual relationship with you, explaining the ethical basis of your refusal.
- Refrain from criticism of other coaches, athletes and officials.

**Make a commitment to providing a quality service to your athletes:**

- Seek continual improvement through ongoing coach education, and other personal and professional development opportunities.
- Provide athletes with planned and structured training program appropriate to their needs and goals.
- Seek advice and assistance from professionals when additional expertise is required.
- Maintain appropriate records.

**Provide a safe environment for training and competition:**

- Adopt appropriate risk management strategies to ensure that the training and/or competition environment is safe.
- Ensure equipment and facilities meet safety standards.
- Ensure equipment, rules, training and the environment is appropriate for the age, physical and emotional maturity, experience and ability of the athletes.
- Show concern and caution toward sick and injured athletes.
- Allow further participation in training and competition only when appropriate.
- Encourage athletes to seek medical advice when required.
- Provide a modified training program where appropriate.
- Maintain the same interest and support toward sick and injured athletes.

**Protect your athletes from any form of personal abuse:**

- Refrain from any form of verbal, physical and emotional abuse towards your athletes.
- Refrain from any form of sexual and racial harassment, racial vilification and harassment on the grounds of disability.
- Any physical contact with athletes should be appropriate to the situation and necessary for the athlete's skill development.
- Be alert to any forms of abuse directed towards athletes from other sources while in their care.

**Provide a non-discriminatory environment for athletes:**

- Ensure the training programme, content, process and/or activities must include all trainees and avoid giving an advantage to any one person/group over another.
- Verbal and non-verbal language must be non-discriminatory.
- Humour must be non-discriminatory.
- Training programme materials such as session plan, videos, hand-outs must be non-discriminatory and unlikely to offend.
- Ensure material and presenters discourage and prevent polarisation of participants.
- Ensure characters (and their names) used in case studies, exercises and examples must be free from stereotypes and unlikely to cause offence.

**Athlete will:**

- Agree to abide by the Code of Conduct.
- Never argue with or verbally abuse an official.
- Always use the appropriate rules and guidelines to resolve a dispute.
- Conduct yourself in a sportsman-like manner and respect fellow athletes, coaches, managers, staff, officials and the achievement of opponents.
- Do not bully or take an unfair advantage of another competitor.
- Cooperate with your coach, manager team-mates and opponents.

- Refrain from possessing or consuming prohibited substances while in NZKWF camps or on tours.
- Do not consume or purchase alcohol, tobacco or liquor while in NZKWF camps or on Tours, without the agreement of the Team Manager and/or Development Squad Coordinator / Coach/Trainer.
- Comply with training, competition, curfew and behaviour requirements directed by Team Manager and Development Squad Coordinator / Coach/Trainer, while in camp or on tours.
- Above all act as a Sports Ambassador for New Zealand whether in private or public.

#### **Technical Official will:**

- Agree to abide by the Code of Conduct.
- Be consistent, objective and courteous when making decisions.
- Be fair, considerate and honest with others.
- Be professional in all actions.
- Ensure language, presentation; manner and punctuality reflect high standards.
- Resolve conflicts fairly and promptly through established procedures.
- Maintain strict impartiality.
- Maintain a safe environment for others.
- Compliment and encourage all participants.
- Condemn unsporting behaviour and promote respect for all opponents.
- Emphasise the spirit of competition rather than the errors.
- Encourage and promote rule changes, which will make the participation more enjoyable.
- Be a good sport yourself.
- Keep up to date with the latest trends, rules and regulations in coaching, judging and officiating, and the principles of growth and development of athletes, particularly young people.
- Remember, you set an example. Your behaviour and comments should be positive and supportive.
- Place the safety and welfare of the participants above all else.
- Give all your people a 'fair go' regardless of their gender, ability, cultural background or religion.

#### **Parent / Guardian will:**

- Agree to abide by the Code of Conduct.
- Remember that children, participate in sport for their enjoyment, not yours.
- Encourage children, to participate, do not force them.
- Focus on the child's efforts and performance rather than winning or losing.
- Encourage children always to compete according to the rules and to settle disagreements without resorting to hostility or violence.
- Never ridicule or yell at a child for making a mistake or losing a competition.
- Remember that children learn best by example.
- Support all efforts to remove verbal and physical abuse from sporting activities.
- Respect official's decisions and teach children to do likewise.
- Show appreciation for coaches, officials and administrators.

**Team Observer will:**

- Agree to abide by the Code of Conduct.
- Respect the rights, dignity and worth of every individual athlete / team member.
- Treat everyone equally regardless of gender, disability, ethnic origin or religion.
- Maintain a safe environment for yourself and others.
- Be positive, supportive and encouraging to all team members and other team observers.
- Act as an Ambassador for New Zealand whether in private or public.

Any breach of the Code of Conduct, or any part of it, may result in disciplinary action under the NZKWF or IWUF Constitution, By-Laws, Regulations and Policies.
